1. Buyer issues an ICPO (Irrevocable Corporate Purchase Order).

3. Buyer countersign and seals the draft contract and sends via email to the OJSC OIL COMPANY ROSNEFT.
4. Buyer pays \$68,850 USD for the Contract to be Registered / Legalized on the Buyers name at the Ministries / Authorities Involved. Upon Payment Confirmation, OJSC OIL COMPANY ROSNEFT issues a DEED OF TRANSFER Document countersigned by the Court, confirming the Full Transfer of the Allocation to the Buyer.
